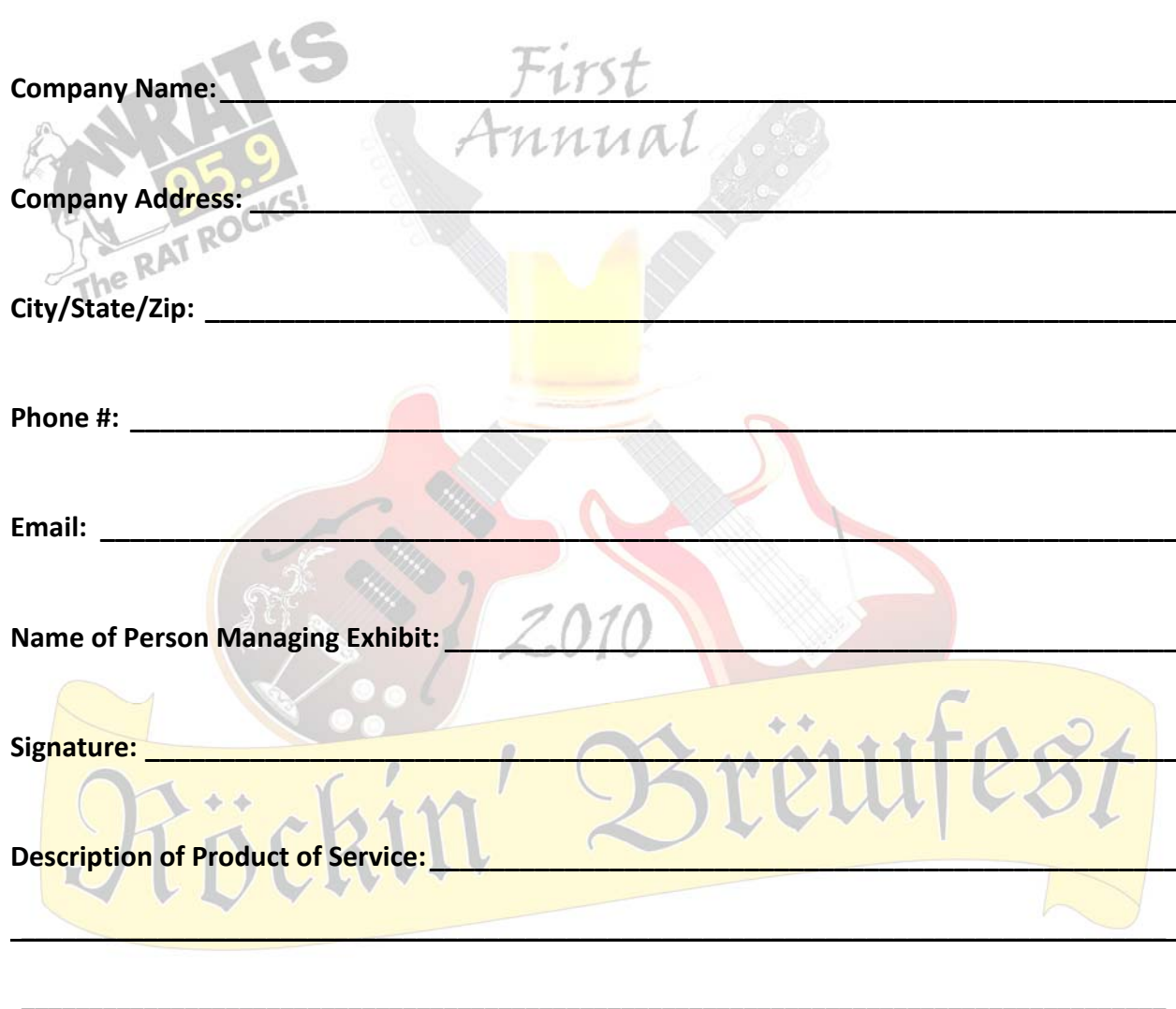

BOOTH COSTS:

Payment should be sent in with completed space registration forms or booth space will not be reserved.

CANCELLATION:

The applicant has a right to cancel this agreement with full refund less \$100 Cancellation Fee within 72 hours of receipt of registration. Cancellations made after this time will forfeit the entire amount of the exhibit space fee.

TERMS OF SPACE AGREEMENT:

The contracted exhibit space is to be used solely for the Exhibitor or whose name appears on the application, and it is agreed that the Exhibitor will not subject or assign any portion of the space without the written permission of the Sun National Bank Center. All applications for space will have the approval of the Sun National Bank Center before official notice of assignment has been made. Sun National Bank Center reserves the right to modify the designated exhibit space in the event a change in the original assignment is necessary.

LIABILITY:

The Exhibitor assumes the entire responsibility and liability for losses, damages, and claims arising from injury or damage to Exhibitor's displays, equipment and other property brought upon the premises of the Center and shall indemnify and hold harmless the Sun National Bank Center agents and employees, and **Rockin' Brewfest** for any and all such losses, damages, and claims. If insurance is desired, the Exhibitor must purchase it. It is further understood and agreed that Sun National Bank Center shall in no event be liable to an Exhibitor for any lost profits, sales, business opportunities or any other type of direct or consequential damages alleged to be due from breach of this contract.
